MAKING OUR FINAL CHOICES, NOW

The recent publicity over the decision to remove artificial nutrition and hydration from Terri Schiavo captured the attention of people throughout the nation. This tragic story also raised awareness about how important it is for every adult to think about these decisions now. Our May Program will feature Gerrie Schipske, a Registered Nurse Practitioner and healthcare attorney. She will discuss the California Advance Health Care Directive law, which allows us to select someone to speak for us if we are unable to communicate and to express our wishes regarding medical treatment in advance.

Ms. Schipske received her Associate of Arts degree in Nursing Science from Goldenwest College and was certified as a Registered Nurse Practitioner from the Harbor UCLA Women's Health Care Nurse Practitioner Program. She also holds an Associate of Arts degree in Liberal Arts from Fullerton College and a Bachelor of Arts in History from the University of California, Irvine. She received her Master of Arts in Legislative Affairs from George Washington University and her Juris Doctor in Law from Pacific Coast University School of Law in Long Beach. She has practiced nursing and law for more than 24 years. She is a member of the United States Supreme Court Bar.

Ms. Schipske has served on the legislative staffs of two members of the US Congress and the California Speaker Pro Tem. She served 4 years on the Long Beach Community College Board of Trustees. Schipske frequently teaches graduate and undergraduate courses at California State University Long Beach in public policy, political science and women's studies.

The co-founder of Long Beach Cares...Ms. Schipske served on the Long Beach Board of Public Health and Human Services for 9 years. Her cable access show, "The Patient Advocate" was featured on Long Beach cable for several years.

What is AAUW's Position on Social Security Privatization?

Privatizing Social Security is bad for women and families --- privatization weakens Social Security due to costly transition costs (making its financial problems worse, not better), slashes benefits to beneficiaries, puts individuals at risk by taking away the social <u>insurance</u> nature of the program (survivors and disability benefits), and increases the national debt

There has been a great deal of rhetoric on strengthening Social Security but the questions about reform revolve around the following issues: raising payroll taxes, raising the retirement age, reducing benefits, and/or increasing the rates of return on the Trust Funds (investing in the stock market – they are currently invested in Treasury Bonds). What about allowing younger workers to divert part of their Social Security payroll taxes to private accounts while continuing to pay full benefits to current and soon to be retirees? It has been estimated that this could cost anywhere from \$600 billion to up to \$2 trillion over ten years or \$6 trillion over 20 years. Right now there is a surplus in the Social Security Fund because there are more than enough taxes withheld from current workers to cover current benefits. The <u>fund</u> will be exhausted (<u>not</u> bankrupt) in 2042 according to Social Security Trustees; the Congressional Budget Office says not until 2052. This gives Congress enough time to devise a fair and equitable way to ensure that this important and socially responsible program continues to benefit all.

The continued viability of Social Security is extremely important to women. They rely more on Social Security because they are half as likely to receive pensions and earn less over their lifetime than do men. Further, women tend to work in jobs that have low rates of pension coverage. In fact, pensions currently provide additional income to only 20% of women over 65. Social Security benefits are the only source of income for 25% of unmarried (widowed, divorced, separated, or never married) women. The poverty rate among elderly would be much higher if they did not have Social Security benefits. In 1997 the poverty rate among elderly women was 13.1%. Without the benefits it would have been 52.2%.

DEPARTMENT OF EDUCATION CREATES HUGE TITLE IX COMPLIANCE LOOPHOLE: THE FOUNDATION POSITION

The Department of Education's March 17, 2005 letter announcing "additional clarification" of its policy for collegiate compliance with Title IX in athletic programs, issued without public input or comment, "clarifies" nothing and, instead, marks a dramatic and unprecedented reversal of the department's previous policy that violates practically every legal principle upon which Title IX's 30-year jurisprudence is based and shifts the burden of compliance from schools to female athletes.

Specifically, the letter and accompanying model survey are contrary to established case law, contradict the Department's prior pronouncements and its Title IX Athletics Investigator's Manual, and ignore the reality that high schools and colleges create sports teams by predetermining sports offerings and encouraging (in the case of high schools) and recruiting prospective athletes (in the case of colleges) rather than requiring a demonstration of interest by existing students.

The gist of the letter is that schools in which females are underrepresented in athletics compared to their proportion in the general student body...and that have not demonstrated a history and continuing practice of expanding opportunities for the underrepresented sex...would be deemed in compliance with the law under Prong 3 of the athletic participation provision if they simply e-mailed a model survey to current students to determine their interests and abilities and found interest by the underrepresented sex to be lacking.
