

An issue that will be discussed at the AAUW National Convention June 18-21 is Proposal #1. **Eliminate the Degree Requirement for Membership.** The rationale is that the purpose of AAUW is to advance equity for women and girls through advocacy, education, philanthropy, and research. Restricting membership is thought to be inherently inequitable and also limits AAUW's influence in the community. The other side of this argument is that if we have always been a membership for women (and in 1987 men) with college degrees and now we don't require one, are we still the same group? An identity crises you might say! Who are we? **DID YOU VOTE?** 

<u>All AAUW members who have paid their full national dues by May 19, 2015, are eligible to vote</u>. Online voting is fast, easy, and secure. To vote online, enter your member ID and voter PIN and click on Start to Vote, below. You can click on the links beside each candidate and item on the ballot for more information. <u>Online voting began April 15 and ends June 19, 2015, at 9 p.m. PDT</u>. No paper ballot requests will be accepted after May 8. Paper ballots must be postmarked by May 26, 2015. Call 800.326.2289 if you need more information.

Regular Board business was conducted at the April Executive Committee meeting. The following motions were made and approved:

- By direction of the Finance Committee, Deloris Mayuga moved that the Executive Committee recommend to the Board of Directors that the Policies and Procedures be amended as follows: Policy 10.b.ii - delete sentence referencing Appendix "A"; Policy 10.d.ii - delete sentence referencing Appendix "A"; Policy 10.e.ii - change percentages to 1. Equities (30-50%) 2. Fixed Income (50-70%); Policy 10.i - delete Appendix A; and Policy 10.j - change number to 10.i.
- Frances Rozner moved that the Executive Committee approve the following 2015-2016 Appointed Officers: Administrative Assistant, Darlene Daclan; Communications Co-Director, Gail Morrison; Communications Co-Director, Brittani Santini-Bolanos; Financial Secretary (2 year), Susan Ramage; Meetings Co-Coordinator, Pam Rayburn; Meetings Co-Coordinator, Lindsay San Miguel; Membership Treasurer (2 year), Denise Montoya; Parliamentarian, Leah Sakacs; Public Policy Director, Flo Pickett. The motion was seconded by Elsa Karen Braden.
- Frances Rozner moved that the Executive Committee recommend to the Branch that Budget (b) in Policies and Procedures be amended, as in the italics, to read: The Convention Fund may pay for travel, registration, lodging and food stipend, for the President-Elect when attending state and national conventions. The same may be paid for the current President when attending the state convention. *In odd-numbered years, for as long as the AAUW National Convention is biennial, the Convention Fund may also pay fro travel, registration, lodging and a food stipend, for the incoming President-Elect.* The motion was seconded by Raquel Sanchez.

At the February Executive Committee meeting, a motion to add the Budget Committee to the standing

committees in the Policies and Procedures was passed. The following was presented at the April Execu-

tive Committee meeting as a follow up to the motion and are to be included in the Policies and Proce-

dures: 16. h. Budget Committee shall be responsible for preparing an initial budget for review at the May

Board of Directors meeting and final adoption at the June Branch meeting Members of the Budget Com-

mittee shall be composed of the President, Vice President (President-Elect), Membership Vice President,

Program Vice President, Communications Director, and Treasurer. The adopted budget shall be moni-

tored by the Budget Chair throughout the year in consultation with the Treasurer.




Literary Ladies Group meets to discuss and compare thoughts on a selected novel, fiction or non-fiction.
