### The Future of Higher Education

The featured speaker for the March 2016 AAUW Long Beach Branch meeting is Dr. Jane Close Conoley. Dr. Conoley is the first female president appointed to California State University, Long Beach in its 65-year history. Dr. Conoley's presentation is entitled, "The (plausible) Death of Public



Higher Education." Her presentation will shed light on America's reputation as the premier higher education system in the world. Yet, many states are increasingly disinvesting in their higher education systems. This has led education economists to predict a complete withdrawal of public support within 50 years.

Dr. Conoley earned her bachelor's degree in psychology from the College of New Rochelle and a Ph.D. in school psychology from the University of Texas at Austin. She is the author of 21 books and her areas of primary interest are interventions with children with disabilities—especially serious emotional disturbance and aggressive children and youth—and family intervention. Dr. Conoley's book "Positive Psy-

chology and Family Therapy" was co-authored with her husband, Dr. Collie W. Conoley in 2009.

This is truly turning out to be a year of activism for women's rights. And our branch is contributing mightily through its members' engagement in developing partnerships to affect change.

In January, we received word from Long Beach City College that it is now an AAUW College/University member. Rose DelGaudio, VP of Human Resources, has been assigned as the representative and the membership

has been added to LBCC's list of institutional memberships for the future. Many thanks to members Ginny Baxter, Alex Bellenger, Mina Naghavi, and Sunny Zia for this successful outcome.

Remember CEDAW – the Committee to Eliminate
Discrimination Against Women? Many years ago our branch sent a
resolution for AAUW to use in the effort to get the U.S. to sign on. The
Senate still has not, making the U.S. one of just six countries in the
world not to have ratified it (Iran is the other large country). So a
grassroots effort is underway in the U.S., led by the Women's
Intercultural Network (WIN) of the U.N., to get U.S. cities to ratify
CEDAW. On January 17, several of our members attended the
Inaugural Brunch of the Iranian Circle of WIN (Alex B., Mina N.,
Marion Smith, Sunny Z. and me), invited by Elahe Amani, an AAUW



national member, who will be speaking at LACIC on March 20 after her attendance at the U.N. Commission on the Status of Women meeting. Also speaking that day was former AAUW CA President, Kathleen Cha. AAUW was well represented. Councilwoman Suzie Price will be advocating that Long Beach ratify CEDAW this year.

In putting together our AAUW LB March 23 screening at the Art Theatre of *Feminist: Stories from Women's Liberation, 1963 - 1970,* the Public Policy group has been reaching out to other women's groups to sponsor the event. Being a sponsor involves no money - it means that the group will promote the event to their members and contacts. We have ten sponsors – all groups interested in promoting a better world for women. In turn, AAUW LB is sponsoring the March 31 screening at the Art Theatre by Pacific Shore NOW of *Equal Means Equal,* a current-day look at women's equality. Come celebrate Women's History Month and bring your friends.

### **Branch Business / Board Brief**



Regular Board business was conducted at the January Board of Directors meeting. The following motions were passed:

- Budget chair, Daphne Ching-Jackson, presented a motion from the Budget Committee to approve presented revised budget. The motion as amended: By direction of the Budget Committee, I move the following: The Budget Committee recommends to the Board that \$275 be transferred from the Convention Fund to cover expenses for a) Other Postage/Office Supplies (+\$150), b) Vantage Postage (+\$100), c) Dues Bills Postage (+\$25) plus transfer an additional \$500 to create a new expense item for Outreach under Administration for a total transfer of \$775 from the Convention Fund and \$39 to total \$814 to bring the budget in line. Second not required.
- Mary Lamo, Co-Vice President, Program, presented the following motion: I move that the following italicized additions be made to the Policies and Procedures, 16. Duties and Composition of Standing Committees, b.: Budget Committee shall be responsible for preparing an initial budget for review at the May Board of Directors meeting and final adoption at the June Branch meeting. Members of the Budget Committee shall be composed of the Budget Chair as committee chair, President, Vice President (President-Elect), Membership Vice President, Program Vice President, Investments Vice President, Communications Director, and Treasurer. The adopted budget shall be monitored by the Budget Chair throughout the year in consultation with the Treasurer. Changes, if any, should be presented to the Board of Directors at the January Board of Directors meeting. Motion seconded by Sharon Westafer.
- Cacilia Kim, Vice President, Co-President Elect, presented the following motion:
  By direction of the Executive Committee, I move that we advance \$450 to rent the Art
  Theatre for Wednesday, March 23 for a speaker and showing of the film "Feminism:
  Stories of Women's Liberation" by Jennifer H. Lee. Donations of \$10 per person will be
  charged to attendees. Second not required.
- Sharon Westafer, Vice President, Co-President Elect, presented the following motion:
   I move that the following be added, as 4b. to Policies and Procedures 4. Branch Records:
   "Original branch records, such as financials and meeting minutes, which are the property of the branch, must remain in the possession of the responsible officers or in branch storage at all times. Members may request duplicate copies of specific items, reimbursing said officer for the cost of duplication. Motion seconded by Linda Patten.
- Deloris Mayuga, Vice President Investments, presented the following motion:
   The Finance Committee recommends to the Board of Directors that the Building Fund CD of \$93,000 be reinvested for 1 year at either Ally Bank, Synchrony Bank, or CIT Bank, whichever has the best interest rate on the day of investment. This CD will be made up of \$43,000 maturing at OneWest Bank on 1/30/2016 and \$50,000 out of the OneWest Bank \$83,000 CD, matured on 1/25/2016. No second required.
- Deloris Mayuga, Vice President Investments, presented the following motion:
   The Finance Committee recommends to the Board of Directors that the Endowment Fund CD of \$33,000 be reinvested for 1 year at either Ally Bank, Synchrony Bank, or CIT Bank, whichever has the best interest rate on the day of investment. This CD will be made up of the remaining \$33,000 maturing at OneWest Bank \$83,000 CD, on 1/25/2016. No second required.

### Magarian Scholarship Motion

On May 21, 2012, the AAUW Board of Directors voted in the affirmative to take the following two actions:

- 1) Recommend to the Branch membership that a scholarship titled the "AAUW-Long Beach Frances Magarian Scholarship" be established by transferring \$16,666.67 and interest earned to date from the Long Beach Branch Endowment Fund to a separate Bank of America Business Interest Maximizer account to fund the Magarian Scholarship for three years. The Magarian Scholarship is to consist of four separate annual scholarships as follows:
  - Two scholarships at \$2,500 to CSULB/California State University, Long Beach students
  - Two scholarships at \$500 to LBCC/Long Beach City College students
- 2) Recommend to the Branch membership that a 5-member scholarship advisory committee be established to research, design and evaluate the framework and procedures for awarding the Magarian Scholarship.

The motion to approve these two actions was brought before the June Branch Meeting on June 2, 2012 and was passed by a two-thirds vote of the members present at the meeting.

While the motion to approve the two actions was passed by the required majority, written notice to bring the motion at the June 2012 Branch meeting did not meet the specified requirements in the AAUW Long Beach Branch governing documents in effect at the relevant timeframe, here fiscal year 2011-2012.

As such, a motion to ratify all Board actions related to the Magarian Scholarship will be discussed at the February 6, 2016 Branch Meeting, notice given in the March 2016 Vantage and brought for a vote to the Branch membership at the March 5, 2016 Branch meeting to cure the procedural defect.

#### The motion is as follows:

"I move that all of the acts and transactions related to the Magarian Scholarship since June 2, 2012 be ratified, confirmed and approved by the AAUW Long Beach Branch membership. The acts and transactions to be ratified, confirmed and approved include the following:

- 1) Establish a scholarship titled the "AAUW-Long Beach Frances Magarian Scholarship" by transferring \$16,666.67 and interest earned to date from the Long Beach Branch Endowment Fund to a separate Bank of America Business Interest Maximizer account to fund the Magarian Scholarship for three years;
- 2) Establish a 5-member scholarship advisory committee to research, design and evaluate the framework and procedures for awarding the scholarships; and
- 3) Any other acts and transactions related to the establishment and awarding of the Magarian Scholarship."

Subsequent Board action on April 15, 2013 specified that the Magarian Scholarship will be awarded during the following 3-year timeframe: 2013-2014 to 2015-2016. After the 2015-16 fiscal year, the scholarship advisory committee will re-evaluate the establishment of the Magarian Scholarship and recommend to the Board whether the Scholarship and the scholarship advisory committee should continue beyond the specified 3-year timeframe and what, if any, changes should be made to the Scholarship framework and awarding procedures.

### Learn about AAUW Bylaws Update

The State Governance Committee has certified the changes made to our branch's bylaws, which were done in accordance with the state mandated amendments and formatting. These changes make the document more succinct and allow for organizational flexibility (where it is appropriate). Further, items have been removed from the bylaws and are under consideration for incorporation into the policies and procedures (i.e. Management of Funds).

Since the document as a whole has been revised, the bylaws will be presented before the board for confirmation in March and, then, to the membership for final confirmation in April. Below are changes that the bylaws committee feel are most pertinent to bring to the attention of the board and membership. If you wish to view the updated bylaws in their entirety, they will be available on the branch's website. - The Immediate Past President has been removed from the Executive Committee (Article VIII. Section 1).
- The Meeting Coordinator and Administrative Assistant are no longer appointed officers; they now serve as administrative chairs (Article VI. Section 1.b).
- Each office may be filled by an officer or co-officers, under which circumstance each shall have a vote as it is provided by the California Corporate Code for incorporated branches (Article VI. Section 1.g).
- Meetings of the Executive Committee shall be held on the call of the president or by written request of two-thirds of its members (Article VIII. Section 3).
- There shall be a nominating committee of seven members, elected by the members of this branch (Article V. Section 1).
- Between meetings of the Executive Committee, a written, conference call or electronic vote may be taken at the request of the president on any question submitted to all voting members of the Executive Committee provided that two-thirds of voting members of the executive committee participate in the vote. The vote shall be counted and shall have the same effect as if at an executive committee meeting. The result of the vote shall be recorded in the minutes of the next board meeting (Article VIII. Section 5).
- The branch shall hold an annual meeting to conduct the business of the branch, including but not limited to, electing officers, establishing dues, amending bylaws and receiving reports. This meeting shall be held between March 01 and May 30 (Article XI. Section 1).
- The quorum shall be fifteen percent of the branch membership. (Article XI. Section 6)
- Notice must be given at least ten days in advance for meetings (Article XI. Section 4), proposed changes to branch dues (Article IV. Section 5.a.1), and by-laws amendments requiring a branch vote (Article XVI. Section 3).
- A member may be suspended or dropped from membership for any conduct that tends to injure AAUW or to adversely affect its reputation or that is contrary to or destructive of its mission according to these bylaws, with action taken following policies and procedures adopted by the AAUW Board of Directors (Article IV. Section 6).

We will be attending a table at the Youth Exploitation and Safety Symposium on Feb. 20<sup>th</sup> and will promote Long Beach City College's new AAUW student affiliate.

### Long Beach Human Trafficking Task Force

<u>Meeting Details:</u> The Task Force meets every 1<sup>st</sup> Thursday of the month from 11:30am to 1:00pm. All meetings are held in the basement of the Lutheran church at 905 Atlantic Ave, Long Beach, CA. The next meeting is March 3<sup>rd</sup>, 2016. At the February meeting, Lyndsey Christoffersen (one of our newer AAUW members and co-founder of the Task Force) and Coalition to Abolish Slavery and Trafficking (CAST) staff hosted a training on labor trafficking and how to identify it. It is estimated that there are 11.4 million women/girls and 9.5 men/boys being trafficked for labor.

Some of the indicators or red flags of labor trafficking are: Living and sleeping at place of work, documents not in individual's control, someone else speaking for a worker, worker always accompanied by another, changing story or "coached story"/ reluctance to speak, no ID documents, expressing fear of police or immigration as reason not wanting to speak, locks or barriers keeping people inside the house, limited accessibility to computers or phones, armed guards/weapons, signs of physical abuse, inhumane living conditions, and working to pay off a debt.



### **Public Policy**



**Title IX is 40 years old this year.** It has been <u>criticized</u> for benefiting girls at the expense of boys. It has been <u>credited</u> with the win of the US Women's Cup in Soccer! Title IX is actually a gender-neutral piece of legislation deigned to ensure equality in education for all students by eliminating sex based discrimination. The regulations are working to provide equal access to better education and career options for both male and female students.

In a democracy, serious change takes a long time and a few very dedicated individuals. But change does come. We are beginning to see results.
