

President's Message





We are mighty working together! The branch's presentation of the film Feminist Stories from Women's Liberation on March 23, engaged over 120 attendees with 17 of our members volunteering that evening; garnered prospective members; made new contacts in the gender-equity community and raised \$820 in net proceeds for Tech Trek from the 143 tickets sold. Special thanks to Flo Pickett who recruited so many



sponsors and volunteers and dealt with the theater; Shelley Arnold, who learned about and managed EventBrite; Elsa-Karen Braden who handled the check payments; Annabel Adams who created the eye-catching flyer; and all of you who brought friends, colleagues and family to be inspired.

With AAUW LB as a sponsor, five more of us attended the Equal Means Equal film on March 30. As with the earlier film, we were blown away by the facts we learned from this movie. The constitution states "We, the people of the United States...", but women have

the people of the United States...", but women have found that equality is not pervasive under federal law. Without a constitutional amendment about gender equality, there will continue to be uncertainty when



issues of gender are brought under scrutiny before the courts.

As a direct consequence of our film screening, one of the sponsors, the National Council of Jewish Women – LB Section, asked our branch to write letters advocating passage of human trafficking bills they support. With approval from your Executive Committee, three letters were sent March 28 on behalf of the branch in support of AB 1760, AB 1761 and AB 1762. I invite you to continue the activism, on another issue, by participating in the Equal Pay Day March event on Saturday, April 23, 10am - noon – organized by member Alex Bellenger. Starts at Victory Park (Atlantic and Ocean) and concludes at City Hall.

Our April branch meeting brought together for the very first time the Title IX coordinators of our AAUW College/University Members: LBCC, Dr. Greg Peterson, and CSULB, Dr. Jeane Caveness. Having a seamless education about consent (with regards to sexual relations), from K-12, through city college to the university, would be helpful for students all along the continuum. Jeane posited that there may be a place for our branch in helping to facilitate the seamlessness. Just one more way we can make a difference with the AAUW tools and passion we possess....

The new proposed bylaws were approved, with several amendments, by the Board of Directors in March, with the branch vote scheduled for the June 4 branch meeting. The newly updated version can be found for review at www.aauw-longbeach.org. Updated Policies and Procedures will next be addressed by committee.

AAUW's mission is accomplished through many avenues. As a member, whatever works for you -advocacy, education, research and/or philanthropy - furthers the mission. So please remember to renew your membership by June 30. Your efforts truly do make a difference in ensuring that women and girls have equity. The May Garden Party is our opportunity to bring prospective members to see the many ways in which we are involved – and to ask them to join us. Looking forward to seeing you on May 14, if not earlier.

Then select Public Policy from the sidebar menu on the left and *Two-Minute Activist* from the sidebar. Put in your email address and click on Sign Up. When you sign up, give your street address or zip code and you will automatically be subscribed to the AAUW California Action Alerts as well as to the national Action Network.

Branch Business and Board Brief



Regular board business was conducted at the March Board of Directors meeting. The following motions were made and passed: Cacilia Kim moved that the AAUW Long Beach Branch Policies and Procedures, section number "2" identified as "Public Policy," be amended as follows (specified in italics):

- b. The Branch may join in coalition with other community groups with the approval of the Executive Committee or the Board of Directors; the approval shall be based on a detailed written request describing the proposed coalition.
- c. The Branch may collaborate with outside organizations to sponsor an event or create a partnership as long as the mission statement and goals of the outside organization adhere to the following requirements: (1) aligns with AAUW's mission and goals; (2) works to advance equality for women and girls; (3) is not political; and (4) is not religious. No monetary exchange is permitted. Approved partner organizations may use the Branch name and logo to publicize sponsored events and partnerships in various media forums, including but not limited to the following: organization's website, event announcements, and press releases. All communications to the public must be approved by the Executive Committee.

The motion was seconded by Denise Montoya.

- Gail Morrison moved the leadership of the Board actively pursue Assistive Listening Devices (ALDs) being available at branch meetings and using the support of AAUW Long Beach, assertively follow a strategy requesting that Old Ranch Country Club (ORCC) or any facility being used for a branch meeting with ALDs, install ALDs for the use of their customers.

 The motion was seconded by Ellen Mathis.
- By direction of the Bylaws Committee, Leah Sakacs moved that the Board of Directors adopt the newly revised branch bylaws.
 - 1) Amending Motion by Fay Denny; seconded by Ellen Mathis: The Board of Directors moves that Article VIII. Executive Committee. Section 3. Meetings be amended by replacing the proposed bylaw, "Meetings of the Executive Committee shall be held on the call of the President or by written request of two-thirds of its members" with the following text: "Meetings of the Executive Committee shall be held monthly, except, June and July."

Amending Motion by Cacilia Kim to the above Motion; seconded by Alex Bellenger. <u>Approved as</u>: The Board of Directors moves that the motion to amend Article VIII. Section 3. to read "Meetings of the Executive Committee shall be held monthly, except, June and July" be amended to "Meetings of the Executive Committee shall be held monthly unless decided otherwise by the president."

2) Amending Motion by Fay Denny; seconded by Sharon Westafer: The Board of Directors moves that Article XI. Meetings of the Members, Section 2. Membership Meetings, be amended by replacing the proposed sentence, "The branch shall hold at least four meetings during the fiscal year," with "The Branch shall hold a minimum of 8 monthly regular meetings of the membership between September and June of each fiscal year."

Friendly amendment by Fay Denny to the above Motion. <u>Approved as</u>: The Board of Directors moves that the motion to amend Article XI. Section 2. to read "The Branch shall hold a minimum of 8 monthly regular meetings of the membership between September and June of each fiscal year" be amended to "The branch shall hold at least four business meetings during the fiscal year"

3) Amending Motion by Fay Denny; seconded by Ellen Mathis: The Board of Directors moves that Article XI. Meetings of the Members, Section 4. Meetings Notices be amended by replacing "Notice of meetings shall be sent to all members of the branch at least ten days prior to the meetings," with the following text, "Notice of meetings shall be published in the Vantage and sent a minimum of 15 days prior to the next meeting of the membership."

Amending motion by SharonWestafer to the above motion; seconded by Denise Montoya. <u>Approved as</u>: The Board of Directors moves that the motion to amend Article XI. Section 4. "Notice of meetings shall be published in the Vantage and sent a minimum of 15 days prior to the next meeting of the membership" be amended to "Notice of meetings shall be published in the Vantage and sent to all members of the branch at least ten days prior to the meetings".

By direction of the Bylaws Committee, Leah Sakacs moved that the Board of Directors adopt the newly revised branch bylaws, with amendments.

Additionally

At the March 5 Branch meeting, the following motion made by Cacilia Kim and seconded by Fay Denny was approved: "I move that all of the acts and transactions related to the Magarian Scholarship since June 2, 2012 be ratified, confirmed and approved by the AAUW Long Beach Branch membership. The acts and transactions to be ratified, confirmed and approved include the following:

- (1) Establish a scholarship titled the "AAUW-Long Beach Frances Magarian Scholarship" by transferring \$16,666.67 and interest earned to date from the Long Beach Branch Endowment Fund to a separate Bank of America Business Interest Maximizer account to fund the Magarian Scholarship for three years;
- (2) Establish a 5-member scholarship advisory committee to research, design and evaluate the framework and procedures for awarding the scholarships; and
- (3) Any other acts and transactions related to the establishment and awarding of the Magarian Scholarship."

Equal Pay Day March




