Work Smart

The Work Smart Planning Committee, along with three additional facilitators, celebrated on December 7 the successful completion of our Long Beach Work Smart pilot. Between early July, when the branch was accepted as a pilot site, and December 7, we trained 20 volunteers to be future workshop facilitators - we lost a couple and gained two from other branches - held three workshops in October and November with a total of 61 attendees (including 2 men), and have developed an initial cadre of organizations interested in pursuing workshops for their constituents. All of this was accomplished with a dedicated group of volunteers.

As a testament to interest in the course: we had one attendee from Culver City who came for an evening workshop via Metro and another who drove in from San Diego for the Saturday workshop. Plus, we met with three LB City Councilpersons—all of whom have offered support. We met with Mayor Garcia, who will assist with this program, with Former Mayor Beverly O'Neill who provided an excellent perspective on marketing and with Congressman Lowenthal's LB Field Officer, Helene Ansel, for a brainstorming session. Helene Ansel is now a LB branch member and a WS Facilitator.

The Planning Committee has decided to proceed beyond the pilot. Next steps: tweaking the workshop script, raising funds (\$1000 per workshop) and recruiting more volunteers. The goal is to have the first 2017 workshop coincide with Equal Pay Day week in April. We're looking forward to training 5000 women in 5 years – and that will require a larger energized and committed volunteer team. Please contact the following

subcommittee chairs if you, or friends of yours, want to be involved in this super effective project: Facilities (Daphne C.), Fundraising (Frances R.), Facilitators/Facilitating (Judy W.), Marketing & Promotion (Elise R.). We're changing the equity equation – it's what we do as AAUW members.

Legal Advocacy Fund

On Sunday, January 8, Daphne Ching-Jackson, Indrani Chatterjee, JoAnn Kuroda, Denise Montoya, Frances Rozner, Sharon Westafer and Judy Willis attended the Los Angeles County Interbranch Council LAF luncheon at Cal Poly, Pomona, to hear Aileen Rizo, an AAUW LAF litigant, speak about her suit against the Fresno County of Education. Aileen filed suit against the Office under equal pay and gender discrimination laws after discovering she was paid less than her male colleague who had less experience and seniority. Ms. Rizo told a wonderful story about her grandmother who was denied an education and how education is so important. Alleen has testified for equal pay laws, and continues her case against the office of education to receive the back pay owed to her. She has since moved on to a job that pays better but continues her case as she believes it will affect women in the future. She also wants to be able to tell her children that she fought for equal pay and that she didn't give up.

The Legal Advocacy Fund provides financial and organizational support to selected cases in the workplace and academia which have the potential of providing equity for both women and men. The financial support helps pay for the filing of briefs, other paperwork, and/ or travel expenses for a litigant to travel to court. Organizational support doesn't provide money but it does provide support in the form of signatory on an amicus brief, an official letter of support, or AAUW may attend the court sessions involving a litigant to show their support.

LAF also provides travel grants to provide transportation costs for a litigant to speak at an AAUW convention or regional meeting, and Campus Action Grants which fund activities on college and university campuses. These activities include educating students about their rights under Title IX, advocating against sexual harassment or assault on campus, DONATE and holding educational panel discussions on equity.
