Around noon on the day of her ascent of El Capitan, a vertical rock formation in Yosemite National Park, Emily Harrington fell. The fall was stopped by her belayer,\* another elite climber. After a 30-minute rest, Ms. Harrington began to climb but slipped again, resulting in a bloodied head from banging against the wall. But she kept going while repeating to herself: "Slow is smooth, smooth is fast." Persistence paid off, and Emily Harrington became the first woman to free-climb El Capitan via the Golden Gate Route in under 24 hours. In addition to Ms. Harrington's accomplishment on November 13th, the first two weeks of November brought us an exciting slate of firsts locally and across the country:

- Suely Saro, about to become the first Cambodian American on the Long Beach City Council
- \* Holly Mitchell, Supervisor-elect for the Los Angeles County Board of Supervisors which becomes the first all-woman board since its inception 150 years ago
- \* Kim Ng, first woman General Manager for the Marlins and first woman GM in Major League Baseball
- \* And of course, Kamala Harris, first Black and first Indian American woman to be elected to the Vice Presidency of the United States

In 1973, Shirley Chisholm, the first Black woman elected to Congress and the first Black candidate for a major party's nomination for President of the United States said: "I ran for the presidency, despite hopeless odds, to demonstrate the sheer will and refusal to accept the status quo. The next time a woman runs, or a Black person, a Jewish one, or anyone from a group that the country is 'not ready' to elect to its highest office, I believe that he or she will be taken seriously from the start. The way should be a little smoother because I helped pave it."

While Ms. Harrington was victorious in her quest, she did not do it alone. Whatever your mountain - a lifetime of economic hardship, an oppressive relationship, a debilitating health condition - we all need people and institutional frameworks that are going to be our belayers. Policies that promote equity for all. Laws that uphold for every individual the right to life, liberty, and the pursuit of happiness.

In this season of gratitude, we are grateful to all the trailblazers helping clear paths for those to come.

#### New Business from October 19, 2020 Board Meeting

- **A. Motion for Signatory Authority P&P Section 7** Patricia Ferrer: I move that AAUW Long Beach Board of Directors approves the following addition to Policy and Procedures, 7. Finance.
  - g. Signatory authority for the AAUW Long Beach bank and investment accounts shall be as follows:
    - i. Checking Account: President, Treasurer, Secretary
    - ii. Building Fund Certificate of Deposit: President, Vice President of Investments, Treasurer
    - iii. Endowment Fund Investment Account: President, Vice President of Investments, Treasurer
    - iv. Other Accounts: President, Treasurer, Secretary

Seconded by Barbara Vangsness. Motion passed 11-0-0.

- **B. Motion for Signatory Authority Secretary P&P Section 14.d.vii** Patricia Ferrer: I move that AAUW Long Beach Board of Directors approves the following change to Policies and Procedures (pg. 19) Section 14. Other Du ties of Officers. Secretary d. The Secretary shall:
  - vii. Be an authorized sole signer on the bank accounts, as are the Treasurer and the President, excluding the Building Fund Account and Endowment Fund Investment Account.

Seconded by Barbara Vangsness. Motion passed 11-0-0.

- C. Motion for Signatory Authority Secretary P&P Section 14.c.iv Linda Patten: I move that AAUW Long Beach Board of Directors approves Section 14 (Other Duties of Officers) c. (Additional Vice Presidents) iv. (Vice President for Investments) add: 3. Have signatory authority on AAUW Long Beach Branch Investment Account as well as signatory authority on the Branch Building Fund, currently held as a Certificate of Deposit.
- Seconded by Patricia Ferrer. Motion passed 11-0-0.
- D. Motion for Signature Authority Building Fund Bank of America Linda Patten: I move that AAUW Long Beach Board of Directors approves changing signers to the AAUW Long Beach Branch Building Fund located at Bank of America-Los Altos; removing Deloris Mayuga and Denise Montoya and adding Jeane Caveness, branch Copresident, and Patricia Ferrer, branch Treasurer.

Seconded by Patricia Ferrer. Motion passed 11-0-0.

- E. Motion for Signature Authority Endowment Wells Fargo Advisors Linda Patten: I move that AAUW Long Beach Board of Directors approves adding signatory approval to Co-President Jeane Caveness, Treasurer Patricia Ferrer for Branch Endowment Fund through The Petrie Group of Wells Fargo Advisors; replacing Deloris Mayuga, former Treasurer as well as former President Denise Montoya.
  - Linda Patten, Vice-President for Investments, will remain as signer of the account.

Seconded by Patricia Ferrer. Motion passed 11-0-0.

**F. Discussion on Ads in the Vantage** – Patricia Ferrer: As the Branch is not using the Bulk Mail rate, Patricia explained that ads could be accepted as a revenue source to cover coast of printing and mailing. The Board discussed how to vet the ads. Patricia will write up a proposal for later consideration.

Co-President Jeane Caveness assumed chair from Co-President Stelet Kim at 7:08.

**G. Adoption of 2020-2021 Strategic Plan** – Stelet Kim: Stelet shared the Career Development Program as part of the Strategic Plan. One aspect could involve AAUW-LB hosting a signature event annually for high school students



which could cover review of their college application essays, mock interviews, and "Ask A..." featuring women from a variety of professions. Another aspect could involve a 4-part series including informational interviews with professional women, career skill building, salary & benefit negotiation skills, and Design Your Life workshop. Stelet asked for adoption of the Strategic Plan by the board.

Herlinda Chico made the following motion: I move that the board adopt the Strategic Plan for 2020-2021.

Seconded by Mary Lamo. Motion passed 11-0-0

The Wednesday, October 21 AAUW Work Smart webinar, coordinated by our branch and facilitated by AAUW, was quite a success: **46 registrants with 27 attendees (including one male).** The facilitator, Andrea Martinez, did an outstanding job of keeping our attention and there were excellent questions and responses. At the conclusion, we provided, via email, the California Equal Pay Laws to all registrants. An attendee responded that she had been considering joining AAUW LB and she has been contacted for membership. We are most grateful to our sponsors, **Los Angeles County Supervisor Janice Hahn** and **Gin-**



**ny's Getaways**, for providing us with this opportunity to engage more women in learning the skills to improve their economic security.

AAUW is now focused on providing online training. Currently, if the branch wants to host a workshop or webinar the **cost is \$750.** Only facilitators affiliated with an organization licensed to provide AAUW Work Smart may train, and at this point, since we do not have an ongoing license, our branch no longer has qualified facilitators. Should AAUW decrease the cost, it might behoove us in the future to consider an annual webinar, marketed to the women in our area. Meanwhile, our AAUW Work Smart in Long Beach committee will focus on promoting the online move-at-your-own-pace AAUW Work Smart workshop, which can be found at salary.aauw.org.

Including this recent 2020 webinar, the AAUW Work Smart in Long Beach initiative has trained **461 women (and men)**. Our branch was an early collaborator with the national office to bring to fruition a program that continues to provide, four years later, outstanding benefits to those who take advantage of it. Our visibility in the community, and our branch membership, have increased due to the program. For this we can all be proud.
