### **Celebrating Special Lives**

The Long Beach/Signal Hill area is home to the largest Cambodian population outside of Southeast Asia. Many of our Cambodian neighbors settled in Long Beach as refugees after fleeing the genocide inflicted by the Khmer Rouge between 1975-1979. April 17th has been recognized by the State of California, the County of Los Angeles, and the City of Long Beach as Cambodian Genocide Remembrance Day. April also marks Cambodian New Year. There are many local

events to remember the history and celebrate the future. This month, we have two incredible Cambodian-American women who will share their life experiences.

Dr. Suely Saro, the first Cambodian-American elected to the LB City Council, represents District 6. Councilwoman Saro, who was the first in her family to graduate from college, holds an Ed.D. in Organizational Leadership from the University of La Verne, is an adjunct faculty member at the School of Social Work at CSULA.



Dedicated to alleviating poverty and empowering women with disabilities in Cambodia, Councilwoman Saro co-founded and is the board chair of Women for Women Foundation (WfWF) which is based in Cambodia. Since 2005, WfWF has helped over 700 women with disabilities increase their economic security by working in a social enterprise program. WfWF is a member of the World Fair Trade Organization (WFTO) allowing its fashionable accessories and products to be sold throughout the world. Susana Sngiem is the first second-generation Cambodian-American woman to serve as United Cambodian Community's (UCC) Executive Director. Her fami-

ly are Khmer Rouge survivors and refugees who immigrated to Long Beach in the early 1980's. Born and raised in central Long Beach, Sngiem attended UC Irvine and received a BA in psychology. After earning her master's degree in social work from USC in 2012, Sngiem began working at UCC. Through her leadership, UCC has doubled their staff and annual budget to promote health and provide youth development, community engagement, and economic development programs.



Sngiem was recognized by former Assemblymember
Bonnie Lowenthal as one of "30 under 30" young women who have made a difference. She currently serves as a board member of Long Beach Community Action
Partnership, APIA Professional Network, Midtown Business and Property Owners
Association, and the Long Beach Homeless Services Advisory Committee.



### From the Co-Presidents

April is Sexual Assault Awareness Month (**SAAM**)—again. Here are some ways to educate, create awareness and connect with others, thanks to the National Sexual Violence Resource Center (NVRC):

- \* Wear teal (the color of sexual assault awareness) on Tues. April 6<sup>th</sup>, the **SAAM** Action Day.
- \* Know your local sexual assault resource center. Long Beach is within the service area of the YWCA Greater Los Angeles Sexual Assault Crisis Services Center; 24-hour hotline: 877-Y-HELPS-U (877-943-5778); Sexual Assault | YWCA Greater Los Angeles (ywcagla.org)
- \* Think about a statement of support you might say when a survivor shares their story with you. For instance, "I Believe You".
- \* Take a stand against victim blaming and wear blue jeans on Denim Day, April 28<sup>th</sup>; check out <u>DenimDayInfo.org</u> for information on this campaign.

No matter what the month, keeping tabs on what is happening with protecting and supporting survivors' rights is important for AAUW members. You may recall that prior to the adoption of the new Title IX rules enacted under former U.S. Department of Education Secretary Betsy DeVos, AAUW CEO Kimberly Churches wrote:

There is no other way to interpret them [the proposed new rules] other than they are intended to deter survivors from reporting issues, including:

- \* Allowing universities to hold trial-style hearings where the survivor of sexual harassment or assault could be subjected to live cross-examinations by representatives of the accused.
- \* Changing the definition of sexual assault and violence on campus from "unwelcome conduct of a sexual nature" to conduct that is "severe, pervasive and objectively offensive that it denies a person access to the school's program or activity."
- Letting universities choose the standard of proof to use either "preponderance of the evidence" or a higher bar of "clear and convincing evidence." Reference:
   Title IX Rollbacks: Has The #MeToo Backlash Begun? AAUW: Empowering Women Since 1881

Now, President Biden has ordered a review of all Title IX policies. On March 8, 2021 he signed <a href="Executive Order on Guaranteeing an Educational Environment Free from Discrimination on the Basis of Sex, Including Sexual Orientation or Gender Identity | The White House</a>. This order directs the Secretary of Education, in consultation with the Attorney General, to conduct that review within 100 days and provide the findings to the Director of the Office of Management and Budget.

A survivor advocacy group, Know Your IX, which has been supported by AAUW, has called on the Biden administration to write a new rule, issue new guidance and conduct a listening tour as part of the Notice-and-Comment Process. Sign up at their website today to receive updates about how you can support the national movement to end campus gender-based violence.

### The Value of Membership

As Membership Treasurer I have been asked two questions: Why should I pay dues? What do I get for paying dues? I can easily give my response, but I wanted to know how National would answer these questions, and I found the following compelling reasons:

"Annual dues currently account for 13 percent of AAUW's annual budget. They help to sustain and grow AAU-W's programs and work that advances equity for women and girls. We believe we can do great things together with your continued support. When you join AAUW, you invest in yourself and in the power of a community." (source: AAUW website 02/25/2019). Today AAUW is 170,000 members strong with over 1,000 branches and 800 college/university members.

In April you received an email with the subject "AAUW Membership Renewal for Fiscal Year 2022" from AAUW National. The email contained specific information about your membership and included the two pieces of information you needed to renew your membership: an MSD (Member Services Database) link to renew online and how to pay by check. You can use the link to update your member record and contact information (except name changes contact <a href="mailto:connect@aauw.org">connect@aauw.org</a>), make a contribution, track your membership, and get history for tax purposes. You can view our branch's member roster and leader contacts.

2022 Membership Renewal is \$108, with \$62 (a \$3 increase from 2021) for National dues, \$20 for AAUW CA dues, and \$26 for LB Branch dues. The National Paid Life Member membership is a one-time tax-deductible amount of \$1,240.

Undergraduate and graduate students who are enrolled in AAUW partner universities and colleges (which includes most of our local universities and colleges) benefit with FREE AAUW National and AAUW memberships. Undergraduate and graduate students who are enrolled in NON-AAUW partner universities or colleges will pay \$18.81 in annual National dues, plus \$10 AAUW CA dues. These students can then join our Branch for only \$13. The Long Beach Branch participates in "Shape the Future" campaigns, giving new members who join at a public event a 50% discount to National dues; and "Give a Grad a Gift" program which gives AAUW members the opportunity to gift one year of National dues to a recent college grad. ### Branch Business February Executive Committee Action

#### **Motion to Update Audit Chair**

I move the following update to the Audit Chair job description: Policies and Procedures, Section 16, Subsection b, Audit Chair, be replaced in its entirety with the wording below:

- b. Audit Chair will
- i. Determine if the branch's financial records and reports were materially misstated due to error or malfeasance and recommend corrective action as necessary
- ii. Perform these actions:
- a. review branch policies and procedures to ensure that the treasurer duties were performed in accordance with requirement
- b. review minutes of the executive committee, board of directors, and branch meetings to ensure that direction provided to the treasurer was performed as directed.
- c. verify that all branch accounts were reconciled at least annually and the yearend balance in the accounts match that of the bank statement(s) and that reports provided at year end match those amounts.
- d. verify that all transactions of \$2,000 or more were recorded accurately and processed in compliance with branch policies and procedures
- e. select ten (10) percent of the transactions under \$2,000 to verify that they were recorded accurately and processed in compliance with branch policies and procedures
- f. take additional measures deemed necessary
- g. initiate the review after the treasurer has compiled the needed records for review, but no later than three months after fiscal year end. If circumstances warrant, reviews may be performed during the fiscal year.
- h. issue a report to the outgoing President, incoming President, and treasurer. If there are findings that require corrective action, a draft report will be provided to the treasurer for review, comment, and action. If corrections are agreed upon and made, the audit chair will verify that the corrections were made, and new fiscal year end reports were prepared and distributed. If the corrections were not made, the final report will state the needed corrections and the reasons why they were not made. If no material misstatements or malfeasance were found in the review, the report will be issued without providing a draft report.

#### Motion to Move Certificate of Deposit - Linda Patten:

The Finance Committee moves to transfer the money from the Bank of America Building Fund #1 Certificate of Deposit no., 8544 at Bellflower Blvd., Long Beach to Citi Bank, located at 5523 Carson Street, Lakewood at the five (5) month rate of 0.25%. At the end of the five-month period, we hope interest rates are more advantageous to the Branch.

#### The Future for Roe v Wade and Choice by Claire Noonan, California Public Policy committee

The times they are changing – a new president and vice-president who support pro-choice, but a sixth very conservative justice is added to the Supreme Court. Abortion rights activists stress state-by-state vigilance to be aware of how reproductive choice is now used as a political tool, says llyse Hogue, recently retired president of NARAL. New anti-choice bills are mainly introduced by the white male religious minority, except in Montana with six abortion-limiting bills introduced this year by conservative female legislators and one male.

For instance, extreme 2021 legislation in Tennessee will allow fathers to veto an abortion. A Texas bill will require a fetus to have a lawyer. Arizona's new bills propose to criminalize a woman who gets an abortion and the doctor who performs it. During a pandemic telemedicine is valuable to prescribe pills for medication abortions. In July 2020 the federal courts temporarily suspended the doctor's visit rule for the first pill, mifepristone, but in January 2021 SCOTUS reinstated the rule. Patients again must visit a doctor for the first pill and get a prescription to obtain the second, misoprostol.

These restrictions have a particularly significant impact on low-income communities, which often include women of color, which are stressed economically by the year-long and counting pandemic. Clinics especially in the South, like West Alabama Women's Center, are constantly searching for money sources to provide reproductive services as well as current needs for newborn assistance. The center focuses on providing financial assistance to the under-served, even when services are 'temporarily' deemed "non-essential". Despite efforts to provide full-spectrum reproductive health care access, dwindling numbers of clinics from the Sun Belt across the Deep South curb the availability of services. In the Navajo Nation, Covid infection is so high that patients need a doctor's note to leave the tribal area for a clinic appointment.

Consequently, vigilance means watching the power of the courts, encouraging reversal of the Hyde Amendment, and backing codification of the Roe v Wade decision. As you know, each woman in California can choose, but support for organizations that oversee the reproductive health rights of women in America are worth the effort.


