<u>US Supreme Court Heard Arguments – Affirmative Action</u>

"I am a product of affirmative action. I am the perfect affirmative action baby. I am Puerto Rican, born and raised in the South Bronx. My test scores were not comparable to my colleagues at Princeton and Yale.

Not so far off so that I wasn't able to succeed at those institutions."

Sonia Sotomayor, Justice, US Supreme Court (first Latina, third woman appointed to the Court)

History: Affirmative Action was part of an Executive Order presented by President John Kennedy in 1961, and a policy put into place for the purpose of having federal contactors hire individuals from marginalized parts of American society, who had experienced discrimination in spite of Constitutional guarantees and civil rights laws written in the 1960's. Basically, affirmative action is a policy in which an individual's color, race, sex, religion, or national origin are taken into account in a selection process (See this link for further explanation:

<u>Supreme Court Challenge, Fall 2022</u> The Supreme Court heard 5 hours of oral arguments on 10/31/22 related to the use of affirmative action in the cases cited - "Students for Fair Admissions v. University of NC" and the secondly - "Students for Fair Admissions, Inc. v. President and Fellows of Harvard College.

What happened when the Supreme Court heard oral arguments about this issue? Among other significant arguments, "US Solicitor General Elizabeth Prelogar, while defending the University of North Carolina affirmative action program, emphasized what gender disparities among attorneys who appear before the Supreme Court signify. She was addressing the questions from conservatives about what affirmative action defenders see as the end point that would allow for the use of race in admissions to end. Prelogar said that it was not about defining a precise quota but acknowledging extreme disparities and how they can "cause people to wonder whether the path to leadership is open." Prelogar was the only female attorney arguing Monday among the six lawyers who participated in the two cases' hearing." More from the Co-Presidents

Arguments/questions asked by the jurists included the following: 1) how would a college or university know when to end affirmative action, or in other words – how would you know when the diversity goals had been met; 2) what are the educational benefits for the students who experience racial diversity; 3) by denying racial diversity, doesn't that deny equal protection under the Constitution; 4) will underrepresented groups decline nationally, as they have in 9 schools which don't utilize Affirmative Action; and lastly 5) the plaintiffs contend that Asians are discriminated against in the Harvard case. (See link on page 2 for additional information.)

Who are the Plaintiffs and why are they suing? The 20,000 members of the nonprofit, Students for Fair Admissions (SFFA), believe that it is unconstitutional to use racial and ethnic classifications for college/university admittance criteria. Most of the membership is Asian and Pacific Islander. (See the website at: https://studentsforfairadmissions.org.) SFFA is an offshoot of an earlier organization, Project on Fair Representation, whose director and sole member is Edward J. Blum. Blum ran against an unopposed candidate in his Texas congressional district, and lost, alleging that gerrymandering had been used to benefit a predominately African American district for the purpose of increasing their voting power. He, and others who joined the suit took their grievance (Bush v. Vera) to the Supreme Court and won, arguing that their Fourteenth Amendment rights had been violated. Blum recruits plaintiffs for Affirmative Action suits within the SFFA online site.

It is likely that the ruling will come late in the spring, as this is a critical issue to colleges, universities, military academies, the military itself, even law firms who depend upon diverse employees, and the larger corporations who are looking to increase the diversity of talented graduates they hire.

Go Long Beach!! Our November AAUW Fund Drive netted a contribution of \$3700 from our Long Beach Branch. This is not counting any donations made via the website. This is a generous and passionate group! Donations were earmarked for Greatest Needs Fund as well as the Mooneen Lecce Giving Circle Special Project Fund, The Economic Security Fund, the Education & Training Fund, and the Legal Advocacy Fund.

In this year celebrating 50 years of Title IX, we want to highlight the work of the **Legal Advocacy Fund.** LAF was created in 1981 by AAUW members and has provided millions of dollars to bring justice and gender equity through the legal system. AAUW allocates \$100,000 annually to help fund landmark cases seeking legal redress issues involving Title IX, as well as those of equal pay, pregnancy discrimination, sexual harassment, and sexual assault.

Two current cases include <u>Joseph v. Board of Regents of the University System of Georgia et al</u> and Paige v. USAID. In the first case, MaChelle Joseph successfully led the women's basketball team at Georgia Institute of Technology. The university's athletic department provided Coach Joseph and her team significantly fewer benefits and resources than it did to the men's team. After Coach Joseph filed a complaint about this discriminatory treatment, the university suspended and ultimately terminated her employment.

The second case involves three women who each worked for USAID for more than 27 years in overseas posts and achieved the highest rank in the Senior Foreign Service. But in 2016, each discovered that, despite their seniority and higher rank, they were paid considerably less than dozens of lower ranking and less experienced male Senior Foreign Service officers. Changes to the Nominations process

Frances Rozner & Carol Clanton, immediate past and current Nominations Committee Chairs

Purpose of proposed changes: easing the responsibilities of the Branch President. Rather than appointing all the members of the Nominations Committee, the President will appoint the Nominations Committee Chair. The Chair will then recruit the Committee members.

Reason for this Vantage statement: The Bylaws motion requires approval of the branch membership. The Policies and Procedures motion requires Board approval. It is good policy to notify the voting parties in advance.

Bylaws: Article IX. Nominations and Elections; Section 1. Nominations; a.:

<u>Currently:</u> a. There shall be a nominating committee of at least five members, consisting of the Immediate Past President as Advisor with the remaining four members and a committee chair appointed by the President. The first meeting shall occur no later than October 1 each year.

<u>Proposed:</u> a. There shall be a nominations committee of at least five members, with a Committee Chair appointed by the President. The committee shall consist of the Immediate Past President as Advisor with the remaining four (or more) members recruited by the Committee Chair. The first meeting shall occur no later than October 1 each year.

Policies and Procedures: 13. Nominations Committee, a. and b.:

- <u>Currently:</u> a. The President shall make appointments to the nominating committee by no later than August 1. The President shall appoint the committee Chair.
 - b. The immediate past Membership Vice President shall be one of the appointed members of the nominating committee.
- <u>Proposed:</u> a. The President shall appoint the Nominations Committee Chair by no later than August 1.
 - b. The Immediate Past Membership Vice President shall be one of the members of the Nominations Committee.

Policies and Procedures: 15. Other Duties of Officers, a. President. ix.:

Currently: ix. Shall appoint members to the nominating committee.

Proposed: ix. Shall appoint the chair of the Nominations Committee.

- 1. **Motion to move Building Funds to Citibank:** Linda Patten moved that we deposit \$93,000.00 from the Building Fund to Citibank branch at 5535 E. Lakewood Blvd, Lakewood Ca 90713. An Investment of \$93,000.00 for a return of at least 2.75% would be adding approximately \$2500.00 to the Building Fund. The motion was seconded by Ginny Baxter. The motion was unanimously approved.
- 2. **Motion to approve Title IX event:** Rita Powell moved as the chair of the AAUW Long Beach Title IX ad hoc committee, that the Board of Directors approve as presented the event to recognize Title IX and its Celebration of the Champions at the Billy Jean King Tennis Center in March 2023. Linda seconded the motion. The motion was unanimously approved.
- 3. **Motion for the Board to use Reserve Funds for Title IX event:** Rita Powell moved that as chair of the AAUW Long Beach Title IX ad hoc Committee, that the Board of Directors recommend to Branch Membership that the Reserve Fund will provide funding not to exceed \$4000 for the Title IX event approved by the Board of Directors. Any funding received from outside donors of AAUW National (Community Action Grant) not spent, should be returned to the Reserve Fund. The motion was seconded by Mary Lamo. The motion was unanimously approved.

Member Spotlight


