There is a lot to celebrate this month—one thing is Women's History month. We have accomplished so much and have lots of tasks ahead of us. It is hard to believe that women only got the right to vote in national elections in 1920. Obtaining the 19th amendment was a long and difficult battle. There were conflicting efforts even among women. Maybe we needed several views. The more orthodox approach by heroes such as Carrie Chapman Catt and Susan B. Anthony competed with the more aggressive tactics of those like Alice Paul.

The most disturbing piece of the movement was to keep black women like Ida B. Wells and Frances Ellen Watkins Harper from full participation was repugnant. Black women had worked with their white sisters to obtain the vote and then were thought to be "damaging" to the effort, so not allowed a seat at the table, particularly as it applied to public efforts such as marches. Ida B. Wells did not stand for it and marched as well. Not something for us to be proud of as women. We must understand that we are stronger working together. Let's make sure we all celebrate International Women's Day on March 8!!!

There are other things to celebrate this month. March 21 is the International Day for the elimination of racial discrimination. This applies to all ignored, disenfranchised, and excluded people around the world. This day includes the celebration of the end of apartheid in South Africa. In 1966 the day was established to help end racial discrimination around African countries and has extended to around the world. We have not met the goal of ending racial discrimination yet, by any measure.

We also have the Holi Festival this month. The Hindu festival celebrates the arrival of spring, which includes love and new life. You may have heard of it as the Festival of Colors. "Playing Holi" involves the throwing of colors (like flowers, herbs, spices) to others as a way to bring people of all levels together. If you have not seen clips of this process, please do look it up. It seems like great fun!

March 14 is also Pi Day. It is a celebration of the math constant Pi. The 14th was chosen as the first three digits of Pi include 3, 1, and 4. Pretty great way to celebrate math and science!

there are things to celebrate. Let's keep these in mind as we navigate through this challenging period. It helps us to keep our focus on the affirmative things we can do.



The following motions were passed at the January 20, 2025 Board Meeting:

1. Motion by Darlene Daclan to Adjust Budget for Remainder of 2024-25 Fiscal Year

"By direction of the Budget Committee, I move that the following adjustments to the budget for the remainder of the 2024-2025 fiscal year are approved. The adjustments are:

an increase of \$280 to the Membership budget, adjusted budget = \$630 a decrease of \$100 from the President's Expenses, adjusted budget = \$250 a decrease of \$39 from Liability Insurance, adjusted budget = \$611 a decrease of \$10 from Registration-Charitable Trust, adjusted budget = \$25 a decrease of \$51 from Other Postage/Office Supplies, adjusted budget = \$74 a decrease of \$80 from Yearbook Printing, adjusted budget = \$570"

2. Motion by Frances Rozner to Modify P & P 19

I move that Policies and Procedures 19. Branch Projects be modified as follows:

"On behalf of Scholarship Committee, I move by direction of the AAUW Long Beach Frances Magarian Scholarship Committee that the total amount of the scholarships be increased from two to three for Long Beach City College students and the amount to be increased from \$500.00 to \$1,000.00 per recipient for the academic year 2025-2026. And, the total amount of scholarship recipients at California State University at Long Beach be increased from two to three, for the academic year 2025-2026, in the amount of \$2,500 per recipient."
