Building Power through Partnerships — WONDER Tech Fest, November 5-6

Casual partnerships, such as volunteering to support the Wonder Tech & Innovation Festival (WTIF) in downtown Long Beach, are the first step for building stronger collaborations. The mission of the non-profit **Wonder Women Tech (WWT)** is “to highlight, celebrate, educate, and amplify women, BIPOC (Black, Indigenous, and people of color), and the underrepresented in Science, Technology, Engineering, the Arts, Math (STEAM) and innovation”. Led by its dynamic founder, Lisa Mae Brunson, this event marked its ten-year anniversary.

In the lead up to November 5, it seemed to check many of the AAUW boxes:

- Target audience. A gathering of educated women with technical interests.
- High-level women speakers. Leaders willing to share their best practices and experiences.
- Diverse and inclusive community of local women with participants from all over the country.
- Non-partisan. Discussions over two days focused on developing careers and networking.

Even the best-laid non-partisan plans could not escape our political world. This year WWT, as a DEI-type non-profit, lost essential Federal Government funding. Then the Federal Government shutdown impacted travel, and many speakers and attendees cancelled reservations. The Convention Center cost became unfeasible for WWT, and all participants and volunteers were notified the event had to be downsized. WWT leadership took quick action to salvage their event by moving to more affordable space in downtown City Place. Ticket holders and volunteers were notified, and all communications were straightforward and considerate. Wonder Tech Fest became a more intimate gathering with a packed line-up of presentations and discussions.

Since the event was now split between two buildings, it was a 5-minute trek from our branch table to main stage sessions, which may have decreased the foot traffic for us; however, the advantages to having an AAUW branch presence far outweighed disadvantages:

- AAUW brand visibility to a wider audience. Most attendees had never heard of AAUW.
- Low stress volunteer roles and stimulating interactions over the course of a few hours.
- We enabled another women’s organization achieve their career event in the face of extreme adversity.

If you see the following members at our Dec 6th holiday gathering, ask about their experience at Tech Fest: Faye Alperin, Valerie Armstrong, Frances Rozner, Dawn Ide, Mary Ann Takemoto, Judy Willis, and Lynne Katz supported our branch table. Seema Nanda and Juliet Wurr escorted attendees and speakers, as well as the branch table. Gay Witten supported the Tech Fest registration table both days. All these volunteers deserve a big thanks for representing us well!

AAUW: Non-Partisan but Political

After viewing AAUW-CA's excellent webinar, "Project 2025 Impacts on AAUW Values – One Year Later," I was aghast at how the current Administration's policies and initiatives undermine AAUW's Mission and programs central to AAUW's Policy Priorities. As a non-partisan organization, how, for example, can we turn a blind eye to eliminating the Department of Education, defanging Title IX, and extracting DEI programs from all Federal Government entities?


These actions, outlined in the Heritage Foundation's Project 2025, and adopted as policy by the current Administration, contradict AAUW's vision of equity and equality for women and girls, among other things. From AAUW's inception, education has been the bedrock of our efforts to even the playing field for women and girls.

In their webinar, AAUW-CA's Public Policy Co-chairs Missy Maceyko and Amy Hom examined how Project 2025 represented a "...creeping authoritarian effort[s] to undermine fair representation, trusted information, and democratic norms in our country." California's Proposition 50 energized AAUW, and other like-minded organizations, to protect our state from such Federal encroachment. A get-out-and-vote campaign and information about Prop 50, including potential benefits, were consistent with our Mission and nonpartisan commitment. In advancing a pro-democracy message, AAUW contributes to preserving and advancing democracy and our public policy priorities, they explained.

In the conclusion of the webinar, California's Public Policy team offered non-partisan actions we can engage in to support AAUW's Mission and Public Policy Priorities. In a hostile political environment, we mustn't be complacent. The team suggested two activities in which AAUW members could participate.

- ⇒ Advance legislation by participating in AAUW's spring Lobby Days.
- ⇒ Use Bluesky, Resistbot and respond to Action Alerts.

By January 2026, AAUW-CA will be reviewing bills in the California Senate and Assembly in preparation for our Lobby Days. Next month, I'll report on legislative initiatives AAUW-CA is following, and how we can respond to Action Alerts.

Our branch is working towards achieving five stars a second time this fiscal year. This article will focus on the most challenging of the five criteria – Advancement. In the month of November there was a fundraiser for AAUW's 9110 Greatest Needs Fund, a vital source of unrestricted support that allows AAUW to respond quickly and effectively to emerging challenges and opportunities. Donations made by branch members prior to December 1st were matched by AAUW National, resulting in double the impact. Our Branch will also make a “branch contribution” to national-level funds via the motion passed during the November 17, 2025 Executive Committee meeting. (See page 5)

The two funds that are highlighted are:

4513 – Defend Higher Education

The Defend Higher Education Fund will enable AAUW to elevate the critical higher education issues impacting women, mobilize advocates across the country, provide strategic resources to students, staff and faculty on campus, and fuel investments in the infrastructure and technology necessary to move our mission forward. Your support ensures AAUW can effectively fight on behalf of women on campuses across the country and ensure that AAUW remains a trusted and powerful voice for equity.

4514 – Public Policy General

The Public Policy Fund is focused on increasing the impact of our Action Network through growing the number of advocates across the country and providing timely, accurate, and actionable information about our key issues. This fund helps equip branches across the country with timely, customized talking points on core policy issues like Title IX, student debt, and pay equity. Support to this fund enables AAUW to reach and energize new advocates—strengthening our collective impact in the fight for gender equity in education and the workplace.

A third potential Advancement goal is to increase our **Legacy Circle** by just one member.
